A review of the last three years annual accounts has shown that the club has consistently received approx. £1,500 each year in membership fees.

Over £400 of the fees are given back to members through subsidising the Team Relays each year.

The remaining funds are spent on things such as club affiliation, club equipment, website, membership system, coaching courses, venue hire and awards etc.

Approx. £5,300 per year is spent on the pool hire of Ibstock Leisure Complex which is similar to amount received in from the two swim sessions per week.

The account balance at year end is usually around £3,000 to ensure that we can cover for any eventuality.
